Gorilla Best Pet Halloween Costume Contest**

A purchase will not improve chances of winning.

CONSUMER DISCLOSURE: You have not yet won.

PARTICIPANTS MUST BE AT LEAST 18 YEARS OLD AS OF THE DATE OF ENTRY and reside in the United States.

By entering this Promotion (contest/drawing), you accept and agree to be bound by these Official Rules. Any violation of these rules, at Sponsor's discretion, may result in disqualification.

1. TO ENTER, follow these steps:

Part 1

Run dates: October 1 through October 15, 2015 at 11:59 pm.

Step 1

Leave a comment on our [Facebook page](#) with a photo of your pet dressed in their Halloween costume. Include his or her name.

Step 2

[Sign up for our email list.](#) Your sign up finalizes your entry. If you are chosen as one of our winners, we'll use the information you used when you signed up for our email list. (If you signed up in the past, please sign up again.)

Complete both steps by October 15, 2015 at 11:59 pm.

VOTING PERIOD: October 16 through October 31 at 11:59 pm.

By 5 pm EST on October 16, the Gorilla team would have selected its top 8 entries based on what the team members feel are the most creative and original costumes.

Part 2

While not mandatory to enter, here's how you can vote and score votes for your pet. If your pet makes the top 8, he or she will be placed in a Facebook Photo Album where the public will get the chance to vote for their favorite.

1 like = 1 vote

Share the contest with your Facebook followers and ask them to vote. This could be in the form of sharing your pet's photo (if he or she makes the cut) directly from the contest album or sharing any contest related posts. How you want to get the word out to increase your pet's chances of winning is up to you!

The voting period closes on October 31 at 11:59 pm. We'll announce the winner on or about November 2, 2015.

2. ELIGIBILITY: The Drawing is open to legal residents of the United States. The following persons are not eligible to win the Drawing:

Winner will be announced on Gorilla's social media pages and notified via the information they enter when they signed up for [Gorilla's email list](#). Entrants must be signed up at the time of the drawing in order to qualify.
